## **Emergency Preparedness**



#### **Basic Disaster Supplies Kit**



Make sure your emergency kit is stocked with the items such as water, food, batteries, a flashlight and first aid kit, and maps. Most of the items are inexpensive and easy to find, and any one of them could save your life. Headed to the store? Download a "Build a Kit" list to take with you. Once you take a look at the basic items, consider what unique needs your family might have, such as supplies for pets, or seniors.

After an emergency, you may need to survive on your own for several days. Being prepared means having your own food, water and other supplies to last for at least 72 hours. A disaster supplies kit is a collection of basic items your household may need in the event of an emergency.

#### Be Prepared to Leave

- Make sure your passport has plenty of validity. We recommend at least 6 months and two or more blank pages. Don't forget to check your children's passports--they expire every 5 years! You can find information about renewing passports on **our website**.
- Be sure your igama is valid and that you have a valid exit visa.
- Create an emergency go-bag for each member of your family that includes your passports, certificates of birth abroad for children born overseas, cash in the local currency, cell phone with charger, copies of personal documents (school documents, medical records, etc), and extra clothing. If you have pets, be sure to have their vaccination records.
- If you take medication, make sure to have at least seven days' worth at any given time and have a copy
  of your prescriptions handy.

### New! Saudi Tourist Visas



On September 27, the Saudi government began issuing tourist visas to American citizens. American citizens may now apply for an "e-visa" online prior to visiting the Kingdom, or at an airport upon arrival. Saudi e-visas are generally valid for one year; the maximum allowable stay during a visit is three months. The U.S. government has no control over the issuance or denial of Saudi entry or exit visas and issuance of a visa does not

guarantee entry. Persons holding tourist visas are not authorized to work or study and will not be able to open bank accounts or perform other bureaucratic procedures for which a residence permit (iqama) is required.

**Public Decency:** Saudi officials simultaneously released new guidelines for "public decency" for foreign visitors to the Kingdom. Visitors are instructed to dress "modestly," but abayas and head coverings are not required for female visitors. The guidelines, which are available on the **Visit Saudi** website, include prohibitions on taking photos of persons without their permission, cutting in line, playing loud music, and wearing clothing with profane or obscene images.

**Exit controls:** Please be advised that American citizens, especially if admitted to the Kingdom on a work visa, may still need the permission of a male guardian and/or sponsor to exit the country and will likely need to apply for an exit visa from the Saudi government.





### Consular Updates

Consulate-General Jeddah said goodbye to its old compound and raised the flag at the New Consulate Compound on September 20. Moving the Consular Section to the new compound was a complex operation that required months of planning and coordination between various offices, but thanks to a carefully organized effort, there was minimum disruption to consular services. Section staff are enjoying their new, modern digs in north Jeddah.

On September 18, Consulate General Dhahran hosted a Town Hall at the Dhahran International School. Consul General Korhonen addressed the recent attacks in Abqaiq and Khurais and noted that there had been no changes in security posture at the Consulate and routines were normal. Many attendees were concerned about what to do in the next emergency; the Consulate's Regional Security Officer offered to work with U.S. companies to improve their emergency response capabilities. Dhahran will hold its next Citizen Liaison Volunteer meeting on October 24th.


## **Hajj 2019**

According to the Saudi Arabian government, roughly 2.5 million pilgrims performed Hajj this year between August 7 and 14, including nearly 21,000 U.S. citizens and Lawful Permanent Residents (LPRs). A consular officer and a locally employed staff member visited the VIP Hajj camps in Mecca on August 9 and August 12. Consular employees visited with American and LPR pilgrims and verified their access to medical care, restrooms, food, and lodging.

### Interested in Voting Overseas?



Most Americans residing in Saudi Arabia will be eligible to vote in the upcoming 2020 Presidential election via an absentee ballot. While absentee ballots can be mailed to the United States, many states also accept online registration and votes via email.
